A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE  
BRANCHES OF THE GOVERNMENT

A JOINT RESOLUTION ENTITLED FOR THE EXECUTIVE BRANCH TO  
DETERMINE THE OWNERSHIP OF THE BUILDING FORMERLY UTILIZED  
BY THE HEAD START PROGRAM IN PRYOR, MONTANA, FOR THE  
PURPOSE OF SEEKING USE OF THE BUILDING AS A SENIOR CITIZEN'S  
CENTER FOR THE PRYOR DISTRICT.

WHEREAS, the Head Start Program no longer utilizes a building in Pryor,  
Montana, which has housed the program for a number of years; and

WHEREAS, the ownership of the building is not currently known; and

WHEREAS, the Pryor, or Arrow Creek, Crow Reservation District, is in  
need of a facility to designate as the Senior Citizen's Center to provide services to  
the elderly members of the district including meal services.

BE IT JOINTLY RESOLVED BY THE LEGISLATIVE AND EXECUTIVE  
BRANCHES OF THE CROW TRIBE: That the Executive Branch of the Crow  
Tribal Government determine the ownership of the building located in Pryor,  
Montana, on Tribal trust land that formerly housed the Head Start Program for the  
purpose of designating the building a Senior Citizen's Center for the Pryor District.


