INTRODUCED BY ANGELA RUSSELL, LODGE GRASS REPRESENTATIVE

A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE  
BRANCHES OF THE GOVERNMENT

A JOINT RESOLUTION ENTITLED: TO RECOMMEND TO THE EXECUTIVE  
BRANCH THE NEED TO DEVELOP A SOCIO-ECONOMIC DEVELOPMENT  
PLAN FOR THE CROW RESERVATION.

WHEREAS, many federal grants available through agencies as the U.S. Department of Health and Human Services require socio-economic development strategies and plans to be used as the basis for funding programs that are generally identified within the plan; and

WHEREAS, two proposals submitted to the U.S. Department of Health and Human Services, Administration for Native Americans during 2000 and 2001 for the Crow Tribe were rejected primarily because the Crow Tribe did not have a socio-economic development plan which would justify the need for the program for which the grants monies were sought; and


WHEREAS, the Crow Tribe, because of its limited financial resources, needs to secure financial assistance from both federal and private grant programs for needed programs in all areas of community development (SED strategies).

BE IT JOINTLY RESOLVED BY THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBE: To recommend to the Executive Branch the need to develop a socio-economic development plan and economic development planning within the strategies for the Crow Reservation. Upon completion of this socio-economic development plan, the Economic Development Planner shall prepare a report quarterly to the Legislature on the status of the plan as well as a regular report on any and all socio-economic development planning.

**Codification instruction.** This Joint Resolution shall be codified as an integral part of Title \_\_\_\_, Chapter \_\_\_\_, Part \_\_\_\_.


