**A JOINT RESOLUTION ENTITLED: TO SUPPORT THE SUBMISSION OF A  
GRANT PROPOSAL IN GOVERNANCE TO THE U.S. DEPARTMENT OF  
HEALTH AND HUMAN SERVICES, ADMINISTRATION FOR NATIVE  
AMERICANS,**

WHEREAS, the Crow Tribal Council has had a General Council form of government from 1948 until July of 2001 when a new Constitution was adopted which provides for three branches of government - the Executive, Legislative, and Judicial; and

WHEREAS, the General Crow Tribal Council, held quarterly each year, passed numerous laws which were never systematically organized, codified or annotated; and

WHEREAS, the Crow Tribe requires an accurate reporting and record of all its resolution as legal and binding documents.

**BE IT JOINTLY RESOLVED BY THE LEGISLATIVE AND EXECUTIVE  
BRANCHES OF THE CROW TRIBE: To support the submission of a proposal in  
governance to the U.S. Department of Health and Human Services,  
Administration for Naïve Americans for the purpose of organizing, codifying and  
annotating all laws passed by the Crow Tribal Council.**

**Codification instruction.** This Joint Resolution shall be codified as an integral part of Title\_\_\_\_, Chapter\_\_\_\_, Part\_\_\_\_.


