**LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE  
ADOPTING A SYSTEM PROCESS FOR INTRODUCTION AND PASSAGE OF  
PROPOSED LEGISLATION AND CODIFICATION OF PASSED LEGISLATION**

**WHEREAS**, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians, approved by the Secretary of Interior on July 14, 2001; and

**WHEREAS**, the Secretary of the Legislature has the duty to codify bills passed by the legislature and the duty to distribute to the public said legislation, and

**WHEREAS**, thus, there is a need to establish a formal process for such codification and distribution to the public of passed Bills

**NOW, THEREFORE, BE IT RESOLVED:**

**THE FOLLOWING PROCEDURE IS HEREBY FORMERLY ADOPTED  
AND APPROVED;**

**INTRODUCTION OF PROPOSED LEGISLATION**

- 1. ALL PROPOSED LEGISLATION, LR'S JAR'S OR BILLS MUST BE PROVIDED/PRESENTED TO THE LEGISLATIVE SECRETARY AND ADMINISTRATOR IN A HARD COPY PAPER FORM AND A COMPUTER DISK CONTAINING THE FILE OF THE PROPOSED LEGISLATION IN WORD FORMAT MUST BE PRESENTED. NONCOMPLIANT PROPOSED LEGISLATION SHALL BE REJECTED.**
- 2. ANY AND ALL MODIFICATIONS OF PROPOSED LEGISLATION MUST BE PRESENTED IN BOTH HARD COPY AND ON A DISK CONTAINING A FILE IN WORD FORMAT OF THE MODIFICATIONS. FOR LEGISLATIVE HISTORICAL PURPOSES, ALL CHANGES INCLUDING AMENDMENTS MUST BE IDENTIFIED AND OR TRACKED IN RED OR BLUE INK ON BOTH THE HARD COPY AND THE DISK FILE. THE SUBCOMMITTEE SECRETARY AND OR THE PRESENTOR HAVE THE DUTY TO COMPLY WITH THIS RULE.**

**FAILURE TO COMPLY MAY VOID THE GOING FORWARD THROUGH THE LEGISLATURE OF THE PROPOSED LEGISLATION.**

**CODIFICATION PROCEDURE**

**1. THE LEGISLATIVE ADMINISTRATOR SHALL MAINTAIN AT ALL TIMES THE LEGISLATIVE HISTORY OF THE PASSED LEGISLATION. THIS LEGISLATIVE HISTORY SHALL BEGIN UPON THE FILING OF THE PROPOSED LEGISLATION, TO AND THROUGH PASSAGE OF THE BILL BY THE LEGISLATURE, SIGNATURES OF THE LEGISLATIVE SPEAKER AND SUBMISSION TO THE CHAIRMAN OF THE EXECUTIVE BRANCH FOR EXECUTIVE ACTION.**

**2. UPON RETURN OF THE BILL TO THE LEGISLATIVE SECRETARY AND ADMINISTRATOR, FROM THE EXECUTIVE BRANCH, A CERTIFIED COPY OF THE BILL, COPY OF THE BILL IN WORD FORMAT ON A DISK AND A CERTIFIED COPY OF THE LEGISLATIVE HISTORY SHALL BE FORWARDED TO THE CODIFICATION/ DISTRIBUTER WITHIN FIVE (5) WORKING DAYS OF RECEIPT FROM THE EXECUTIVE BRANCH AND THEN THE LEGISLATIVE SECRETARY SHALL SIGN AND SEAL THE LEGISLATION FOR CODIFICATION. THE LEGISLATIVE ADMINISTRATOR SHALL MAINTAIN A FILE OF ALL ORIGINAL BILLS WHICH SHALL BE FILED IN A SECURE FIRE PROOF FILE IN A SECURE ROOM WITH ONLY LIMITED ACCESS BY AUTHORIZED PERSONNEL ONLY.**

**3. THE CODIFICATION/DISTRIBUTER SHALL CODIFY THE PASSED LEGISLATION AND SHALL MAINTAIN A FILE OF ALL PASSED LEGISLATION INCLUDING THE LEGISLATIVE HISTORY.**

**4. THIS LR SHALL BE POSTED CLEARLY ON THE LEGISLATIVE BULLETINBOARD AT ALL TIMES FOR PURPOSES OF NOTICE TO ALL INTERESTED PERSONS OR PARTIES.**

**5. A FINAL CODIFIED COPY OF THE ACTION FOR THE LEGISLATIVE SESSION SHALL BE PROVIDED AND DELIVERED TO THE JUDICIAL BRANCH OF GOVERNMENT FOR OFFICIAL IMPLEMENTATION.**
