**INTRODUCED BY SENATORS SIDNEY W. FITZPATRICK, JR.,
OLIVER HALF, JR., AND THE CROW LEGISLATIVE BRANCH**

**A LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE
ENTITLED:**

“A LEGISLATIVE RESOLUTION SUPPORTING THE CROW MEN’S HEALTH PROJECT, ITS MISSION AND GOALS OF ENHANCING THE HEALTH OF INDIVIDUALS ON THE CROW INDIAN RESERVATION AND OUTLYING AREAS THROUGH COMMUNITY-BASED PROJECTS. THE OVERALL GOAL OF THE CROW MEN’S HEALTH PROJECT IS TO IMPROVE HEALTH IN THE CONTEXT OF COMMUNITY-BASED PROJECTS DESIGNED TO STRENGTHEN THE CAPACITY OF THE COMMUNITY THEMSELVES TO ASSESS AND TO ADDRESS THEIR OWN UNIQUE HEALTH RELATED PROBLEMS.”

WHEREAS, the Crow Legislative is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians, and

WHEREAS, the Crow Legislature is empowered to adopt legislation, not inconsistent with the Constitution, which is necessary in exercising the duties conferred the three branches of government, ID at b, and

WHEREAS, the health, welfare, and safety of all Crow Members is an essential duty and responsibility of the Crow Government to preserve, promote, and protect, and

WHEREAS, the Crow Men’s Health Project requested a Legislative Resolution supporting their community-based participatory research project, and

WHEREAS, Montana State University, staff and students have been collaborating with members of the Crow Nation on this initiative since 1996, and

WHEREAS, the Legislature enthusiastically supports entities and/or programs that provide services to individuals on the Crow Indian Reservation, and

WHEREAS, the Crow Men’s Health Project has made successful progress in service to improve the health of individuals on the Crow Indian Reservation, and


NOW THEREFORE BE IT RESOLVED:

THE LEGISLATIVE BRANCH OF THE CROW NATION HEREBY THIS ACTION, DOES PROCLAIM SUPPORT FOR THE CROW MEN'S HEALTH PROJECT, ITS PURPOSE AND GOALS IN THEIR CONTINUING EFFORTS TO PROVIDE SERVICES TO INDIVIDUALS ON THE CROW INDIAN RESERVATION.

THIS PROCLAMATION SHALL TAKE EFFECT UPON PASSAGE BY THE LEGISLATURE AND SIGNATURE BY THE LEGISLATIVE SPEAKER AND THE SECRETARY.




