A Legislative Resolution Titled:

**“A RESOLUTION OF THE CROW TRIBAL LEGISLATURE IN SUPPORT OF
ESTABLISHING A MOMENT OF SILENCE IN THE SCHOOLS IN THE
ARROW CREEK DISTRICT”**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter “Legislature”) has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, Legislative Resolution 10-20 “A Resolution of the Crow Tribal Legislature to Establish Branch Policy and Procedure for Legislative Resolutions, Section 1. Branch Policy Regarding Legislative Resolutions,” state

the policy of the Legislature shall be that legislative resolutions are an expression of the voice of the elected Senators of the Crow Legislature, and which is based on the inherent sovereign tribal authority of the Crow Tribal General Council, as delegated to the Legislature under the 2001 Constitution and which shall be categorized as follows:

5. Recommendation Resolutions. Resolutions for making recommendations, statements of support, or endorsements in any public election, the hiring of any public official, or the establishment of government policy by law or otherwise, including federal and state legislation, which may affect the Crow Tribe and its members; and

WHEREAS, the Crow Indian Reservation has recently experienced trauma from recent deaths and other harmful activities such as substance abuse and criminal activity; whereby, the communities are suffering from these events and are in need of healing and community support; and

WHEREAS, the Legislature has been approached by its constituents to support healing with a moment of silence in the schools in the Arrow Creek District; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN
REGULAR SESSION:**

Section 1. That the Legislature hereby supports moment of silence in the schools in the Arrow Creek District to provide students with healing and community support in light of recent traumatic events and for future support during the academic year.

Section 2. This Legislative Resolution take effect immediately upon becoming duly adopted by the Legislature. A copy of this legislation shall be provided to all schools in the Arrow Creek District, upon passage.




