A Legislative Resolution Titled:

A RESOLUTION OF THE CROW TRIBAL LEGISLATURE APPROVING THE ADMINISTRATIVE RULES, POLICIES, PROCEDURES AND REGULATIONS AS ADOPTED BY THE CROW NATION HOUSING BOARD OF COMMISSIONERS

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter “Legislature”) has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Crow Tribal Constitution, federal laws and tribal laws for the governance of the Crow Tribe; and

WHEREAS, the Housing Board of Commissioners (hereinafter “Commissioners”) as established by CLB 17-03 (titled “An Act to Repeal and Replace the Crow Tribal Housing Ordinance”) is the governing and rule-making authority for the Crow Housing Tribal Authority; and

WHEREAS, CLB 17-03, 19-2-107 provides for the Rule-Making Authority of the Commissioners; 19-2-108 provides for the Legislative Approval of the proposed rules during a public comment period; and,

WHEREAS, on October 5, 2017 the Infrastructure Committee held a meeting to review the proposed rules, policies, procedures and regulations as adopted by the Commissioners and a committee recommendation was made to the full legislature to approve the proposal.

NOW, THEREFORE BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATURE IN SPECIALL SESSION:

That the Legislature hereby approves the attached Rules, Policies, Procedures and Regulations as adopted by the Crow Housing Board of Commissioners.

BE IT FURTHER RESOLVED:

This Legislative Resolution shall take effect immediately upon becoming duly adopted by the Legislature; and, the Rules, Policies, Procedures and Regulations shall become effective after they are posted for thirty (30) days public notice pursuant to CLB 17-03, 19-2-108.

In the event that public comment deems a change in the regulations, the Legislature shall make amendments at the conclusion of the public comment period.
