A Legislative Resolution Titled:

“A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CREATE A POSITION OF LEGISLATIVE BRANCH TRAVEL SPECIALIST/ACCOUNTS PAYABLE CLERK “

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter “Legislature”) has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, The Crow Tribal Legislature has restructured the Legislative Branch Finance Office and eliminated the position creating a Travel Specialist/Accounts Payable Clerk; and

WHEREAS, the position is created as a position for Accounts Payable and Travel Specialist to better serve Senators with travel arrangements, and create more accountability and consistency; and

WHEREAS, The Crow Tribal Legislature has determined that it is necessary and proper to create the Travel Specialist/Accounts Payable Clerk as a permanent position.

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN SPECIAL SESSION:

That, the Travel Specialist/Accounts Payable Clerk shall be created for the benefit of the Crow Legislative Branch.

That, the position of Travel Specialist/Accounts Payable Clerk is hereby made permanent as a legislative employee of the Crow Tribal Legislature, and shall be governed by the position description.

BE IT FINALLY RESOLVED:

This Legislative Resolution take effect immediately upon becoming duly adopted by the Legislature.


CERTIFICATION


