A Legislative Resolution Titled:

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO APPROVE THE
POSITION DESCRIPTION FOR THE NEWLY CREATED POSITION OF ACCOUNTS
PAYABLE CLERK /TRAVEL SPECIALIST**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter “Legislature”) has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Tribal Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, The Crow Tribal Legislature has restructured the Legislative Branch Finance Office and eliminated the position, creating the position of Accounts Payable Clerk/Travel Specialist with LR 15-04; and

WHEREAS, this position is created for Accounts Payable/Travel Specialist to better serve Senators with travel arrangements, and create more accountability and consistency; and

WHEREAS, the position description was created to provide guidance and consistency through the duties and responsibilities of the Accounts Payable Clerk/Travel Specialist; and

WHEREAS, the Accounts Payable Clerk/Travel Specialist is a position created to aid in the transition for separation of finances consistent CLB 07-08 Crow Tribal Fiscal Management Act, section 9, each of the three branches of the Apsaalooke Nation will assume control over its own budget with signature authority granted to each Branch Chief.

**NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN
SPECIAL SESSION:**

Section 1. Approval of Position Description for Accounts Payable Clerk/Travel Specialist Legislative Resolution No. 15-04. LR No. 15-04 is hereby amended with the attached position description for the Accounts Payable Clerk /Travel Specialist with duties and responsibilities.

Section 2. Establishment of Position. The position of Travel Specialist/Accounts Payable Clerk is hereby made a permanent legislative employee and shall be governed by the position description.

Section 3. Effective Date. This Legislative Resolution shall take effect immediately upon being duly adopted by the Legislature.


