INTRODUCED BY: JARED STEWART, BLACK LODGE DISTRICT

A BILL FOR AN ACT ENTITLED: AN ACT ESTABLISHING A WEEKEND IN JUNE AS THE DATE FOR THE ANNUAL CROW DAY FESTIVAL.

WHEREAS, it is in the interest of the Crow Tribe to promote and maintain its culture and identity; and

WHEREAS, the annual Crow Day Festival is a celebration of Crow Culture and identity, as well as a time for families to gather; and

WHEREAS, it is necessary for Crow Day planners and Crow families to have a constant date to plan events and gatherings for the festival:

THEREFORE, BE IT ENACTED BY THE LEGISLATURE OF THE CROW TRIBE:

**NEW SECTION**, Section 1. A weekend in June, of each year, shall be designated for the Crow Day festival.
