## **JULY 2002 CROW TRIBAL LEGISLATURE**

### INTRODUCED BY CLIFFORD BIRDINGROUND, SR. CHAIRMAN

A BILL TO CONFIRM THE APPOINTMENT OF DONALD LAVERDURE AS APPELLATE JUDGE OF THE CROW TRIBAL COURT IN ACCORDANCE WITH ARTICLE X OF THE CROW CONSTITUTION AND TITLE 3, CHAPTER III, SECTION 3-3-308 OF THE CROW LAW AND ORDER CODE.

WHEREAS, the Crow Constitution provides for the election process and qualifications for the Judicial Branch Judges shall be in accordance with the Crow Law and Order Code; and

WHEREAS, Title 3, Chapter III, Section 3-3-308 of the Crow Law and Order Code establishes minimum qualifications for the Appellate Judge as well as duties and responsibilities for the Appellate Judge; and

WHEREAS, The Chairman of the Crow Tribe conducted a nationwide search for candidates for the position and after consultation with the other members of the Executive Branch of the Crow Tribe has determined that Donald Laverdure is the best candidate for the position; and

WHEREAS, The Chairman of the Crow Tribe has appointed Donald Laverdure as the Appellate Judge of the Crow Tribal Courts and currently seeks the confirmation of his appointment by the Legislative Branch of the Crow Tribal Government.

#### BE IT ENACTED BY THE LEGISLATURE OF THE CROW TRIBE:

By a majority vote of the members of the Legislative Branch of the Crow Tribe, the Legislature hereby:
