

JULY 2003 CROW TRIBAL LEGISLATURE

INTRODUCED BY CARL E. VENNE, CHAIRMAN
CROW TRIBAL EXECUTIVE BRANCH

A BILL FOR AN ACT ENTITLED "AN ACT ADOPTING THE CROW TRIBAL BUDGET FOR THE EXPENDITURE OF CROW TRIBAL REVENUE FOR THE FISCAL YEAR 2004 ENDING OCTOBER 2004."

WHEREAS, Article IV, Section 3(d) of the Crow Tribal Constitution and Bylaws requires the Executive Branch to prepare an annual budget for the operation of the Tribal Government, including separate budgets for the Legislative and Judicial Branches, and Article IV, Sections 2(d) empowers the Legislative Branch of the Crow Tribal Government to grant final approval or disapproval of the annual budget prepared by the Executive Branch; and

WHEREAS, a budget for the expenditure of Crow Tribal revenue has been developed by the Executive Branch of the Crow Tribal Government for the fiscal year 2004 commencing in October 1, 2003 and ending September 30, 2004 from the following sources of Tribal revenue:

1. General Fund of the Crow Tribe	\$10,530,000
2. 107 th Judgment Fund Interest	\$5,635,000
3. Indirect Cost from federal contracts	<u>\$1,344,000</u>
TOTAL	\$17,509,000

WHEREAS, the Executive Branch will present a line item budget for the scheduled legislative hearing to provide the Crow Tribal Legislature with full budget information for all three branches of the Crow Tribal Government.

BE IT ENACTED BY THE LEGISLATURE OF THE CROW TRIBE:

NEW SECTION. Section 1. Approval of the 2004 fiscal year budget for the expenditure of Crow Tribal revenue. The 2004 fiscal year budget for the expenditure of Crow Tribal revenues in accordance with the budget developed by the Executive Branch and reviewed by the Legislative Branch is hereby adopted by the Crow Tribal Legislature.

AMENDMENT: TO BILL TO ADOPT THE CROW TRIBAL BUDGET FOR THE EXPENDITURE OF CROW TRIBAL REVENUE FOR THE FISCAL YEAR 2004 ENDING SEPTEMBER 30, 2004.


