INTRODUCED BY: SENATOR PATRICK ALDEN, JR. EDUCATION COMMITTEE CHAIR

A BILL FOR AN ACT ENTITLED:
“APSÁALOOKE NATION RESEARCH REVIEW BOARD”

WHEREAS, it is in the interest of the Apsáalooke Nation to promote and maintain its culture and identity with full respect, and;

WHEREAS, to establish a requirement and code to submit proposals for research applying to the Apsáalooke Nation and its members and descendants, and;

WHEREAS, it is necessary to promulgate rules and regulations consistent with this Bill with whom the designated authority are authorized to implement, creating the Apsáalooke Nation Research Review Board (ANRRB), and;

WHEREAS, the ANRRB will have authority to review any and all proposed research for approval or disapproval, as well as have authority, through the Apsáalooke Nation, to maintain and/or own any and all data, presentation materials, manuscripts, professional papers/reports, and any other distributable materials before they are published, and including, but not limited to, repatriation of all that is Apsáalooke, and;

WHEREAS, the ANRRB will maintain on file all documents under the supervision of the Secretary of the Executive Branch and the Secretary of the Legislative Branch for at least six years, and;

THEREFORE, BE IT ENACTED BY THE CROW TRIBAL LEGISLATURE:

This bill will be effective upon the signature of the Chairman of the Executive Branch of the Apsáalooke Nation.

The Executive Branch of the Apsáalooke Nation, upon approval of the Legislative Branch, will appoint an individual as a Chairperson, and an individual with a thorough knowledge of the Apsáalooke Culture; whom may be the Cultural Department Director and/or designee, and an individual from the Education Department; whom may be the Education Cabinet Head and/or designee, and individuals from the Legislative Branch; whom may be the chair of the Education Subcommittee and/or the Cultural Subcommittee and/or other appropriate Legislative Subcommittee Chair, and, if and when appropriate, a Medical officer from the Indian Health Service and Health Department Director or Designee.

All to review and decide on the impact of each research proposal reviewed. These appointed individuals responsibility will be outlined in a policy and procedure document.

Upon appointment, the chairperson of ANRRB will commence a meeting with constituency within sixty days of approval of this bill to create a Policy and Procedure Code document to be presented to the Crow Tribal Legislature for approval or disapproval effectively coordinate the Board and the Apsáalooke Nation Research Review Code. This code should be developed no later than twelve months after approval of this bill.

Prior to the granting of any research authority to any person or entity, development of a proposed policy or procedure code or rules or regulations, involving the Tribe or its members, the proposal(s) shall be presented in the form of a Bill to the Legislature for final approval or rejection.

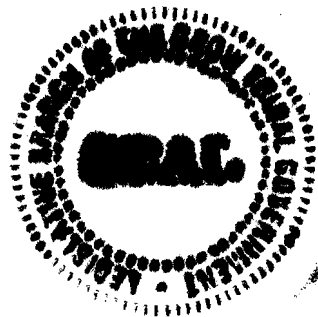




