INTRODUCED BY CARL E. VENNE, CHAIRMAN CROW TRIBAL EXECUTIVE BRANCH

A BILL FOR AN ACT ENTITLED:

"RESCISSION OF CLB07-15 AMENDMENTS TO FISCAL MANAGEMENT ACT."

WHEREAS, pursuant to the Memorandum of Agreement (the "MOA") between the Legislative and Executive Branches of the Crow Tribe, dated August 3, 2006, and approved by LR06-04 (August 10, 2006), the Legislature passed CLB07-08, the "Fiscal Management Act" (hereinafter, the "Act") on April 10, 2007, the Chairman of the Executive Branch approved the Act on April 12, 2007, and the Act became effective on April 12, 2007; and

WHEREAS, the Legislature passed a certain Bill to Amend the Fiscal Management Act as CLB07-15, in the October 2007 Session (the "FMA Amendments"), the Chairman of the Executive Branch vetoed the FMA Amendments on November 16, 2007, and the Legislature overrode the Chairman's veto on January 10, 2008; and

WHEREAS, before the FMA Amendments passed by CLB07-15 became effective, the Chairman of the Executive Branch filed on April 8, 2008, a Verified Complaint for Declaratory Judgment and Permanent Injunction with the Crow Tribal Court, in a case entitled *Venne v. Stone, et al.*, Civ. Case No. 08-087 (the "Litigation"), alleging among other things that CLB07-15 exceeded the Legislature's powers under the 2001 Crow Tribal Constitution and Bylaws (the "Constitution"); and

WHEREAS, the Tribal Court granted a preliminary injunction which, among other things, enjoined the Legislature from enforcing the FMA Amendments in CLB07-15; and

WHEREAS, the Legislature has filed motions and an appeal disputing, among other things, the jurisdiction of the Tribal Court to grant preliminary injunctive relief; and

WHEREAS, the Executive and Legislative Branches of the Crow Tribal Government have agreed that it is in the best interests of the Crow Tribe to avoid a Constitutional confrontation on the issue of the FMA Amendments and have therefore entered into a settlement agreement whereby the Litigation will be completely dismissed upon passage of legislation in the form of this Act which eliminates and rescinds the FMA Amendments made by CLB07-15;

NOW, THEREFORE, BE IT ENACTED BY THE CROW TRIBAL LEGISLATURE:

Section 1. Rescission of FMA Amendments. The amendments to the Fiscal Management Act made by CLB07-15 are hereby eliminated and rescinded, and such amendments, including all changes made to the Fiscal Management Act by CLB07-15, shall have no force or effect.

Section 2. Reaffirmation of Fiscal Management Act. The Fiscal Management Act as enacted by CLB07-08 (April 12, 2007), excluding any amendments prior to the date of this Act, shall remain the valid and effective law of the Crow Tribe.

CERTIFICATION
