JOINT ACTION RESOLUTION NO. JAR0201

INTRODUCED BY: REPRESENTATIVE ANGELA RUSSELL, VALLEY OF THE CHIEFS DISTRICT

A JOINT ACTION RESOLUTION PROMOTING THE ESTABLISHMENT OF A VISITORS CENTER AND REST STOP AT THE JUNCTION OF U.S. 90 AND HIGHWAY 212, AT THE CROW AGENCY, MONTANA, WITH THE ASSISTANCE OF STATE AND FEDERAL DOLLARS.

WHEREAS, the junction of U.S. Highway 90 and Montana Highway 212 is located one mile south of Crow Agency, Montana, and is a heavily trafficked area; and

WHEREAS, currently the closet rest stops on U.S. 90 from Crow Agency are located from thirty-five (35) to the north and to seventy (70) miles to the south from the Crow Agency area; and

WHEREAS, this junction is a prime tourist area as it is close to the Little Big Horn Battlefield, a major route to Yellowstone Park and the Black Hills, and the site of numerous tribal activities as the Crow Fair, the Real Bird Re-Enactment, and Ultimate Warrior Competition;


THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBE:

New Section. Section 1. To promote the establishment of a Visitors Center and Rest Stop at the junction of U.S. 90 and Highway 212, near Crow Agency, Mt. with the assistance of state and federal dollars.

New Section. Section 2. Codification instructions.


