A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCH OF THE CROW TRIBAL GOVERNMENT

A JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATIVE BRANCH REQUESTING THE CROW TRIBAL EXECUTIVE BRANCH ALLOW CROW TRIBAL YOUTH WHO ARE CROW TRIBAL MEMBERS AND MEMBERS OF THE TRIBAL BOYS AND GIRLS CLUB, 4-H CLUB OR OTHER APPROPRIATE AGRICULTURAL CLUB, TO REQUEST ONE HEIFER CALF PER YOUTH OUT OF THE CROW PRIZE BULL BREEDING PROGRAM FOR EDUCATIONAL PURPOSES.

WHEREAS, children of the Crow Reservation are the Tribe's most important assets requiring positive influences, role models and experiences to become responsible and productive citizens; and

WHEREAS, agriculture plays an integral part of the economy on the Crow Indian Reservation and Tribal member farmers and reachers need experience early in life to increase their likelihood of success in the future; and

WHEREAS, the Executive Branch of the Crow Tribe purchased prized bulls for use in the Crow Prize Bull Breeding Program which provides breeding services for Crow Tribe Ranches in exchange for one calf per year returned to the Tribe as consideration for such services; and

WHEREAS, the Legislative Branch of the Crow Tribe resolves that providing Tribal youth the opportunity and responsibility to raise a calf may increase their interest and knowledge in the field of agriculture as well as their chances of success in the future, therefore, donating one calf to each eligible youth is an appropriate use of a tribal asset for an educational purpose.

BE IT RESOLVED BY THE LEGISLATIVE BRANCH OF THE CROW TRIBE:

That the Crow Tribal Legislative Branch requests the Crow Tribal Executive Branch donate one heifer calf to each eligible youth for educational purposes. Such youth must be a Crow Tribal Member and a member of the Crow Tribal Boys and Girls Club, 4-H Club or other appropriate agricultural club. The heifer calf shall be provided out of the Crow Prize Bull Breeding Program; and

In order to qualify for the donation, the youth must provide a plan detailing where the calf will be place, which can be with an Indian or Non-Indian Rancher, and how the youth intends to care and manage his/her stock. The youth shall provide a report of his/her experiences and success or lack of success to his/her respective club who shall forward such reports to the appropriate

Legislative Committee and Crow Tribal Director of Natural Resources.

FURTHER, that rules and regulations be established by the sponsor, other Legislative and the head of Natural Resources and the Head Resources provide a status report on this project at each quarterly session of te Legislature in 2002.
