A RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBAL GOVERNMENT

A RESOLUTION ESTABLISHING A LITTER CONTROL AND RE-CYCLING PROGRAM FOR THE CROW RESERVATION.

WHEREAS, the Crow Tribe has established road signs in various parts of the reservation urging members to "Keep Crow County Beautiful"; and

WHEREAS, the Crow Tribe has never established a litter control and recycling program except as individual households; and

WHEREAS, the Crow Reservation has a number of major highways that traverse the reservation and litter strewn along these highways leaves a poor impression of our beautiful country as well as having a negative impact on tourism; and

WHEREAS, the Crow Tribe with its various offices are herein required to begin a litter control and re-cycling program on all tribal premises, including tribal housing, and will include, at the onset, the recycling of aluminum cans and newspapers; and

WHEREAS, the Legislative and Executive Branches of the Crow Tribe should adopt policies and procedures for the litter control and re-cycling program, and to report to the Legislature on these developments at the next Legislative session;

THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBE:

<u>New Section.</u> Section 1. To establish a litter control and re-cycling program for the Crow Reservation beginning with tribal premises, the develop policies and procedures for this program, and to report on development at the next Legislative session.

New Section. Section 2. Codification instructions.
