OF THE CROW TRIBAL GOVERNMENT

A JOINT RESOLUTION OF THE CROW TRIBAL AND LEGISLATIVE BRANCHES TO  
APPROVE THE CONSTRUCTION AND FUNDING OF A COMMUNITY HALL TO BE  
LOCATED ON TRIBAL TRUST LAND IN SAINT XAVIER, MONTANA

WHEREAS, the Big Horn voting district of the Crow Reservation lacks a meeting and  
gathering place for Tribal government functions and community meetings; and

WHEREAS, the community of St. Xavier is conveniently located within the Big Horn  
voting district of the Crow Reservation; and

WHEREAS, the Executive and Legislative Branches of the Crow Tribe resolve that the  
community member, government officials and votes of the Big Horn district are entitled to a  
community hall in St. Xavier to provide a gathering place for Tribal governmental functions and  
community meetings.

BE IT RESOLVED BY THE EXECUTIVE AND LEGISLATIVE BRANCHES OF THE  
CROW TRIBE:

That the Crow Tribal Budget of fiscal year 2003 be amended by the Crow Tribal  
Executive Branch to provide funding and planning to establish a community hall located on  
tribal trust land in Saint Xaiver, Montana with such amendment to be approved by the  
Legislative Branch of the Crow Tribal Government.
