A JOINT ACTION RESOLUTION OF THE CROW TRIBAL EXECUTIVE AND LEGISLATIVE BRANCHES TO APPROVE THE CREATION AND FUNDING FOR A BOYS AND GIRLS RANCH FOR TROUBLED YOUTHS WHICH SHALL BE LICENSED FOR THERAPEUTIC CARE.

WHEREAS, there exists a need to create and fund a boys and girls ranch for troubled youths on the Crow Indian Reservation; and

WHEREAS, the Pryor Creek Ranch or the Soap Creek Ranch are ideal locations for the creation of a boys and girls ranch for the Crow Indian Reservation; and

WHEREAS, the boys and girls ranch that is created by this resolution must be licensed for therapeutic care.

BE IT RESOLVED BY THE EXECUTIVE AND LEGISLATIVE BRANCHES OF THE CROW TRIBE:

That the Crow Tribal Budget of fiscal year 2002 be amended by the Crow Tribal Executive Branch to provide funding and planning to create and fund a boys and girls ranch that is licensed for therapeutic care to provide services for troubled youths at either the Pryor Creek Ranch or Soap Creek Ranch.
