**A JOINT ACTION RESOLUTION OF THE EXECUTIVE AND LEGISLATIVE BRANCHES
OF THE CROW TRIBAL GOVERNMENT**

**A JOINT ACTION RESOLUTION OF THE CROW TRIBAL EXECUTIVE AND
LEGISLATIVE BRANCHES REQUESTING \$35,000.00 FROM THE (BUREAU OF INDIAN
AFFAIRS) BIA ROADS PROGRAM FOR CROW TRIBAL ADMINISTRATIVE CAPACITY
BUILDING FOR ROADS ON THE CROW INDIAN RESERVATION.**

WHEREAS, The Crow Tribal Executive and Legislative Branches of the Crow Tribe are the duly elected governing bodies representing the Crow Tribe of Indians of the Crow Reservation and are empowered to act on behalf of the Tribe. All actions are within the inherent power and authority granted in the Crow Constitution.

WHEREAS, by Federal Register notice of January 10, 2002, (Vol. 67, No. 7, pages 1290-1295), a Temporary Rule was published which authorizes each Federally Recognized Tribe to apply for a \$35,000.00 contract award from its servicing Regional Office of the Bureau of Indian Affairs (BIA) for administrative capacity building. According to the Rule, the described purpose of these funds is to provide tribes with critical resources to develop inventory data, long-range transportation plan, transportation improvement programs and other information necessary to distribute funds under a new funding formula for allocation of Indian Reservation Roads program funds under the Transportation Equity Act for the 21st Century (TEA-21); and

WHEREAS, the Crow Tribe recognizes the importance of long-range transportation planning pursuant to building its administrative capacity, as an enhancement to its exercise of tribal sovereignty, for the health and well-being of its members and desires to obtain all available resources to conduct this valuable work.

**BE IT JOINTLY RESOLVED BY THE EXECUTIVE AND LEGISLATIVE BRANCHES OF
THE CROW TRIBE:**

That the Executive and Legislative Branches of the Crow Tribal Government hereby approve submission of a Proposal to Contract with the BIA's Rocky Mountain Regional Office, under the provisions of P.L. 930638, as amended, to pursue and conduct long-range transportation planning toward preparation of a Long-Range Transportation Plan for the Crow Indian Reservation, in accordance with the Statement of Work submitted with this application.
