### JOINT ACTION RESOLUTION NO. JAR0231

## INTRODUCED BY: ANGELA RUSSELL, VALLEY OF THE CHIEFS DISTRICT

A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBAL GOVERNMENT

WHEREAS, the Yellowstone Cut Throat Trout (<u>Oncorhynchus clarki bouvieri</u>) population has decreased to only 40 genetically pure populations in Montana and the Crow Reservation is home to 4 of these populations; and

WHEREAS, the Crow Tribe has signed a Cooperative Conservation Agreement with Montana Department of Natural Resources, United States Forest Service, United States Bureau of Land Management, United States Fish and Wildlife Service, Bureau of Indian Affairs and Yellowstone National Park to collaborate in the conservation of the Yellowstone Cutthroat Trout. The Conservation Agreement obligates the Crow Tribe in meeting the goals of the Conservation Plan; and

WHEREAS, the Yellowstone Cutthroat Trout is a species of special concern and warrants special management to protect existing populations through conservation plans, population restoration, habitat protection and habitat restoration. A species can be placed on the special concern list if scientific evidence shows that historical population numbers have decreased to a point that it could be place on the Endangered Species List or population numbers are down due to habitat destruction or encroachment by humans; and

WHEREAS, there is the possibility of a future listing of Yellowstone Cutthroat Trout on the Endangered Species List under the Endangered Species Act.

THEREFORE BE IT RESOLVED By the Executive and Legislative Branches of the Crow Tribe: to list the Yellowstone Cutthroat Trout (Onchorhynchus clarki bouvieri) as a *species of special concern* and must by protected through conservation practices until scientific evidence warrants it no longer needs protection.
