## JULY 2004 CROW TRIBAL LEGISLATURE JOINT ACTION RESOLUTION NO. <u>JAR04-04</u>

JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCHES ENTITLED: "AN ACT TO PROVIDE FINANCIAL ASSISTANCE TO THE WYOLA DISTRICT TO COMPLETE CONSTRUCTION ON THE MIGHTY FEW RODEO & HORSEMAN ARENA."

WHEREAS, the Crow Tribal legislature is authorized to adopt resolutions for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians, approved by the Secretary of Interior on July, 2001; and

WHEREAS, the Crow Tribe recognizes that Indian Rodeo is a positive activity for Crow Reservation Communities and has donated Rodeo Arena equipment to the Wyola District; and

WHEREAS, the Crow Tribe also recognizes the established Mighty Few Rodeo & Horseman Committee who oversee the operation and construction of the Rodeo Arena; and

WHEREAS, the Mighty Few Rodeo & Horseman Committee has volunteered and sponsored fund raising events but is still in need of financial assistance to complete construction of the Community Rodeo Arena.

## BE IT ENACTED BY THE CROW TRIBAL LEGISLATURE:

THAT, the Crow Tribal Legislature hereby directs the Crow Tribal Executive Branch to work with the Mighty Few Rodeo & Horseman committee.

FURTHER, that the Crow Tribal Executive Branch shall allocate \$50,000.00 from the FY2005 Crow Tribal Budget to the Wyola District 'Mighty Few Rodeo & Horseman Committee' for completion of said Rodeo Arena.

FINALLY, the Crow Tribal legislature requests the appropriate Crow Tribal Agency to take all necessary action to begin the financial allocation in a timely manner.
