JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND THE CROW TRIBAL EXECUTIVE BRANCH ENTITLED:

"REQUEST FOR CONFIRMATION OF THE EXECUTIVE BRANCH APPOINTMENT OF ASSOCIATE JUDGE DALE KINDNESS"

WHEREAS, Article X of the Crow Tribal Constitution and Bylaws provides that the election process for the Judicial Branch judges of the Crow Tribal Government shall be in accordance with the Crow Law and Order Code; and

WHEREAS, a vacancy exists in the position of Associate Judge of the Crow Tribal Court; and

WHEREAS, Title 3, Section 3-3-310 of the Crow Law and Order Code, as amended by the Legislative Branch and approved by the Executive Branch, provides that vacancies in the Tribal Court judicial positions shall be filled for the unexpired term by appointment of the Chairman of the Executive Branch and confirmation by the Legislature; and

WHEREAS, the Chairman of the Executive Branch has appointed Dale Kindness to fill a vacancy on the Crow Tribal Court; and

WHEREAS, the person appointed by the Chairman of the Executive Branch fulfills the statutory requirements for appointment;

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE:

The appointment of Dale Kindness as Associate Judge of the Crow Tribal Court to fill the unexpired term until the next general election of judges is **CONFIRMED**.
