JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND
THE CROW TRIBAL EXECUTIVE BRANCH ENTITLED:

**“RESOLUTION TO URGE SUPPORT OF THE UNITED NATIONS
DECLARATION ON THE RIGHTS OF INDIGENOUS PEOPLES”**

WHEREAS, the Crow Nation is a sovereign nation with inherent rights, privileges, and powers; and,

WHEREAS, the Crow Nation wishes to recognize and support the rights of Indigenous Peoples throughout the world; and,

WHEREAS, since 1977, indigenous leaders and others have worked to draft and have approved a Declaration on the Rights of Indigenous Peoples; and,


WHEREAS, the Crow Nation wishes to support these efforts and to express its respect for the freedom, equality, and cultural ways of Indigenous Peoples;

**NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE AND THE
EXECUTIVE BRANCH OF THE CROW TRIBE:**

1. That we support the United Nations Declaration on the Rights of Indigenous Peoples; and,
2. That we urge the United States to fully support adoption of the Declaration by the General Assembly of the United Nations, in order to strengthen the relationship between the United States and the Indigenous Peoples within its boundaries as well as to support the rights of Indigenous Peoples everywhere; and,
3. That we urge the General Assembly of the United Nations, and indeed all of the nation-states of the world, to resolve any outstanding issues with the text of the Declaration so that the Assembly may fully recognize the rights of Indigenous Peoples.

CERTIFICATION

I hereby certify that this Joint Action Resolution to Urge Support of the United Nations Declaration on the Rights of Indigenous Peoples was duly approved by the Crow Tribal Legislature with a vote of 14 in favor, 1 opposed, and 0 abstained, and that a quorum was present on this 18th day of July, 2007.


