107<sup>TH</sup> ADVISORY COUNCIL OF ELDERS”**


**WHEREAS**, the 107<sup>th</sup> Advisory Council of Elders plays an important role in advising the elected officials of the Crow Nation in numerous areas;

**WHEREAS**, the 107<sup>th</sup> Advisory Council of Elders has expressed a wish to adopt a formal emblem as an official seal for their use;

**WHEREAS**, the proposed emblem reflects Crow Tribal values and displays the official Crow Tribal Seal, as well as the traditional name for our people, Apsaalooke Nation;

**WHEREAS**, the proposed emblem is an appropriate visual representation of the 107<sup>th</sup> Council of Elders of the Apsaalooke Nation.

**NOW THEREFORE BE IT RESOLVED** that the attached graphic, also shown below, be officially declared and recognized as the emblem and official seal of the 107<sup>th</sup> Advisory Council of Elders.




**EXECUTIVE ACTION**
