JOINT ACTION RESOLUTION OF THE CROW TRIBAL EXECUTIVE BRANCH AND  
CROW TRIBAL LEGISLATIVE BRANCH ENTITLED:

**“CONFIRMATION OF THE APPOINTMENT OF HENRY PRETTY ON TOP  
TO THE POSITION OF HEALTH AND HUMAN SERVICES  
CABINET HEAD”**

**WHEREAS**, Joint Resolution No. 02-04, “A JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATIVE AND EXECUTIVE BRANCHES TO CONFIRM CHAIRMAN’S SELECTIONS FOR EXECUTIVE BRANCH CABINET HEADS AND CEO” requires that the Chairman of the Executive Branch select Cabinet Heads and CEO, and that individuals selected for these positions be confirmed into their positions after a hearing before the Legislative Branch; and

**WHEREAS**, the position of Cabinet Head of Health and Human Services is of vital importance to ensuring the health and welfare of members of the Crow Tribe; and

**WHEREAS**, it is critical that the position of Cabinet Head of Health and Human Services be filled by an individual with extensive experience in the areas of healthcare and human services; and

**WHEREAS**, the Chairman of the Executive Branch has selected Henry Pretty On Top to serve as Cabinet Head of Health and Human Services; and

**WHEREAS**, Mr. Pretty On Top, is a member of the Crow Tribe and lifelong resident of the Crow Reservation, with a commendable history of service to the Crow Tribal Community;




**WHEREAS**, Mr. Pretty On Top has appeared before the Legislative Branch for a hearing before the Legislative Branch during the January 2010 Session;




