JOINT ACTION RESOLUTION OF THE CROW TRIBAL EXECUTIVE BRANCH AND CROW TRIBAL LEGISLATIVE BRANCH ENTITLED:

"CONFIRMATION OF THE APPOINTMENT OF HENRY PRETTY ON TOP TO THE POSITION OF HEALTH AND HUMAN SERVICES CABINET HEAD"

WHEREAS, Mr. Pretty On Top, is a member of the Crow Tribe and lifelong resident of the Crow Reservation, with a commendable history of service to the Crow Tribal Community;

WHEREAS, Mr. Pretty On Top has extensive experience in the field of health and human services, including over three decades of work experience in the healthcare and health policy fields, and is extremely well-qualified to serve in this capacity;

WHEREAS, Mr. Pretty On Top has appeared before the Legislative Branch for a hearing before the Legislative Branch during the January 2010 Session;

BE IT RESOLVED BY THE EXECUTIVE AND LEGISLATIVE BRANCHES OF THE CROW TRIBE that Henry Pretty On Top is hereby confirmed as Cabinet Head of Health and Human Services.
