





JOINT ACTION RESOLUTION NO. JAR 10-05

INTRODUCED BY CEDERIC BLACK EAGLE, CHAIRMAN
CROW TRIBAL EXECUTIVE BRANCH

JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND THE
CROW TRIBAL EXECUTIVE BRANCH ENTITLED:

**A JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND
THE CROW TRIBAL EXECUTIVE BRANCH ENTITLED: "A RESOLUTION
SUPPORTING THE CROW NATION RESERVATION TRANSIT SYSTEM"**

WHEREAS, the Executive and Legislative Branches of government of the Crow Nation share the sincere desire to improve services and benefits available to the people they serve; and,

WHEREAS, good public transit is of fundamental importance for providing Crow Nation citizens and others with access to education, shopping, medical services, and in fulfilling other needs; and,

WHEREAS, the rural nature of the Crow Reservation raises special transportation challenges, especially for those who cannot drive or do not have access to safe personal transportation; and,

WHEREAS, early stages of transit planning have been completed and the results published in the December 2007 Technical Assistance Report prepared by LSC Transportation Consultants, Inc. for the Community Transportation Association of America; and,

WHEREAS, federal funds are available to help implement the transit system as envisioned in the 2007 technical report; and,

WHEREAS, a fully implemented transit system will help Crow Nation citizens and others to travel safely and result in additional opportunities for medical treatment, economic opportunity, and other vital needs and services,

**NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE
AND THE CROW TRIBAL EXECUTIVE BRANCH:**

That the Crow Nation Reservation Transit System be implemented as a priority of the Executive Branch as soon as possible; and,

BE IT FURTHER RESOLVED, THAT:

The Executive Branch Chairman shall appoint a member of the Crow Tribal General Council as Public Transit Director. The Public Transit Director shall be the lead administrator of the Crow Tribal Office of Public Transit, which shall administer the Crow Nation Reservation Transit System;

BE IT FURTHER RESOLVED, THAT:


The Crow Tribal Office of Public Transit is authorized to apply for and receive any federal or state grant funding related to public transit on the Crow Indian Reservation. Provided that as soon as any grant requests are made by the Office of Public Transit, an executive summary describing the grant shall be provided to the Legislature with the right to attain a full copy of the grant application reserved by the Legislature;

FINALLY, BE IT RESOLVED, THAT:

Beginning on July 1st of 2010, and for every financial quarter thereafter, the Crow Tribal Comptroller shall provide to the four elected Executive Branch officers and the Revenue Committee of the Legislature, a notarized financial statement attesting to the total grant funding received in accordance with this Resolution and a line-itemization of all expenditures of such grants made in the fiscal year to date, and in the most recent financial quarter. Any such financial statements shall be signed by the Comptroller attesting to its accuracy and completeness.

CERTIFICATION

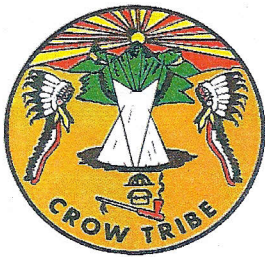
