JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND THE CROW TRIBAL EXECUTIVE BRANCH ENTITLED:

"RESOLUTION APPROVING THE CROW TRIBE'S LIMITED WAIVER OF SOVEREIGN IMMUNITY IN THE CONSTRUCTION CONTRACT FOR PHASE 3 OF THE CROW TRIBE WATER AND WASTE WATER IMPROVEMENT PROJECT."

WHEREAS, the Crow Tribe is prepared to begin the bid process for phase 3 of the water and waste water improvement project in order to make critical infrastructure improvements for the community of Crow Agency, which includes both water main and sewer main replacement; and

WHEREAS, Exhibit A in the Supplementary Conditions to the General Conditions of the Construction Contract for construction of phase 3 of the water and waste water improvement project, attached hereto and incorporated by reference, requires a limited waiver of sovereign immunity for the limited purpose of enforcing the Owner's obligations under the construction contract; and

WHEREAS, the Chairman of the Executive Branch has authority and responsibility pursuant to the "enumerated powers" in Article IV, Section 3 of the Constitution and Bylaws of the Crow Tribe of Indians to represent the Crow Tribe in negotiations with Federal, State and local governments and other agencies, corporations, associations, or individuals in matters of welfare affecting the Crow Tribe, and to "negotiate limited waivers of sovereign immunity when such a waiver is necessary for business purposes in accordance with Article V, Section 2(f) of [the] Constitution;" and

WHEREAS, the Legislative Branch has authority and responsibility pursuant to its "powers and duties" in Article V, Section 2(f) of the Constitution to "grant final approval or disapproval of limited waivers of sovereign immunity by the Executive Branch of Government when waivers are necessary for business purposes;" and

WHEREAS, the Crow Tribe and the community will greatly benefit from the infrastructure improvements from phase 3 of the water and waste water improvement project, and the limited waiver of sovereign immunity required by the contracting conditions for the construction contract is necessary for the business purpose of construction in phase 3 of the water and waste water improvement project;

NOW THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE AND THE CROW TRIBAL EXECUTIVE BRANCH:

Section 1. That the limited waiver of sovereign immunity set forth in Exhibit A in the Supplementary Conditions to the General Conditions of the Construction Contract for construction of phase 3 of the water and waste water improvement project, attached hereto and incorporated by reference, is hereby approved.

Section 2. That the approval granted herein is effective on the date of approval of this Resolution.
