LEGISLATIVE RESOLUTION NO. <u>LR08-15</u>

INTRODUCED BY: SENATOR BEVERLY M. SHANE, MIGHTY FEW DISTRICT

LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE ENTITLED:

"ASCENDING PAY INCREASE FOR THE CHAIRMANS AND SECRETARYS OF THE COMMITTEES OF THE CROW TRIBAL LEGISLATURE".

WHEREAS, The Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians, approved by the Crow Tribal General Council July 14th 2001 and signed by the Secretary of the Interior on December 04th 2001; and

WHEREAS, the Crow Tribal Legislature hereby declares that Legislative Resolutions are those items that merely express an opinion of the Legislature, or request/recommend another entity to take a certain action (the request or recommendation has no binding effect, but rather expresses the Legislatures support for something.) Legislative Resolutions shall also be used for internal legislative actions and shall only be binding upon the Legislative Branch; and

WHEREAS, the Crow Tribal Legislature Revenue Committee convened a meeting on July 2nd 2008, approving a pay increase for the Chairman's and Secretary's of the Committees; and

WHEREAS, the current hourly rate for a Senator is paid at \$23.00 per hour

WHEREAS, the Crow Tribal Legislature Revenue Committee approved a \$1.50 pay increase per hour for an elected committee chairman; and

WHEREAS, the Crow Tribal Legislature Revenue Committee approved a \$1.00 pay increase per hour for an elected committee secretary.

NOW THEREFORE, BE IT ENACTED BY THE CROW TRIBAL LEGISLATURE:

THAT, THE CROW TRIBAL LEGISLATURE SHALL COMPENSATE ALL ELECTED COMMITTEE CHAIRMANS AT AN ADDITIONAL \$1.50 PER HOUR TOTALING \$24.50 PER HOUR.

FURTHER, THE CROW TRIBAL LEGISLATURE SHALL COMPENSATE ALL ELECTED COMMITTEE SECRETARYS AT AN ADDITIONAL \$1.00 PER HOUR TOTALING \$24.00 PER HOUR.

FURTHER, AFTER THIS LEGISLATIVE RESOLTION IS APPROVED BY THE CROW TRIBAL LEGISLATURE, THE APPROVED HOURLY RATE SHALL TAKE EFFECT IMMEDIATELY AND ALL ELECTED SENATORS SHALL ONLY BE COMPENSATED FOR ONE POSITION AS CHAIRMAN OR SECRETARY.

FURTHER, ALL SENATORS WHOM ARE ELECTED AS SPEAKER OR SECRATARY OF THE HOUSE SHALL REMAIN COMPENSATED AT THE ELECTED OFFICE HOURLY RATE AS SPEAKER AND SECRETARY.

FURTHER, UPON APPROVAL THIS LEGISLATIVE RESOLUTION DOES NOT INCLUDE RETRO COMPENSATION.

FINALLY, THE APPROVED HOURLY RATE SHALL NOT BE EXCEEDED, UNLESS OTHERWISE APPROVED BY THE CROW TRIBAL LEGISLATURE BY AMENDING THIS LEGISLATIVE RESOLUTION. ALL RELEVANT DOCUMENTS ARE ATTACHED HERETO AS EXHIBIT (A).
