"To Modify the FY 2009-2010 Budget to Reflect Pay Scale for Permanent Law Clerk"

LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE APPROVING AND ADOPTING A PAY SCALE FOR THE PERMANENT LAW CLERK

WHEREAS, the Crow Tribal Legislature is a separate and distinct branch of government under the 2001 Constitution of the Crow Tribe; and

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians, approved by the Secretary of the Interior on July 14, 2001; and

WHEREAS, the Crow Tribal Legislature has determined that it is necessary and proper to make the position of law clerk permanent and to secure funding accordingly.

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE:

THAT, the position of law clerk be paid at the rate of \$25.00 per hour with cost of living adjustments as needed.

FURTHER, that the law clerk is a full-time employee of the legal office of the Legislative Branch and is subject to all personnel rules and guidelines which apply to Legislative Branch staff generally.

FURTHER, that the FY (fiscal year) 2009-2010 budget be adjusted in order to compensate the law clerk in accordance with this legislative resolution.

FINALLY, the action directed herein shall take effect immediately upon approval by majority vote the Crow Tribal Legislature and the Legislature directs that the Legislative Branch Speaker and staff take all necessary actions to enact this policy.
