LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE APPROVING, ADOPTING AND DIRECTING TO HIRE AND EMPLOY GERALD "JAY" HARRIS AS A LAW CLERK FOR THE LEGISLATIVE BRANCH

WHEREAS, the Crow Tribal Legislature is a separate and distinct branch of government under the 2001 Constitution of the Crow Tribe; and

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians, approved by the Secretary of the Interior on July 14, 2001; and

WHEREAS, the Crow Tribal Legislature requires technical and professional support in the exercise of its constitutional authorities, including legal research and preparation of legal documents; and

WHEREAS, the position of "temporary law clerk" was established for a period of 90 days by consensus of the Personnel and Revenue Committees on November 3, 2009; and

WHEREAS, Gerald "Jay" Harris began work as the "temporary law clerk" on November 16, 2009; and

WHEREAS, the Crow Tribal Legislature has determined that it is necessary, appropriate and proper to extend the "temporary law clerk" position beyond February 16, 2009 and, therefore, has made the position permanent under Legislative Resolution 10-01.

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE:

THAT, upon approval by majority vote the Crow Tribal Legislature that Gerald "Jay" Harris be hired as the permanent law clerk.

FINALLY, the action directed herein shall take effect immediately upon approval by majority vote the Crow Tribal Legislature and the Legislature directs that the Legislative Branch Speaker and staff take all necessary actions to act as herein directed.
