INTRODUCED BY THE CROW LEGISLATIVE BRANCH AND SENATOR OLIVER HALF, JR.

A LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE ENTITLED:

"A RESOLUTION ESTABLISHING THE TRANSPORTATION COMMITTEE"

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians; and

WHEREAS, the Legislature has reviewed the issues related to TRANSPORTATION; and

WHEREAS, the issues related to TRANSPORTATION are unique and should be reviewed separately because of the magnitude of issues related thereto.

NOW THEREFORE, BE IT RESOLVED:

BY THIS ACTION THE CROW LEGISLATURE HEREBY DOES ESTABLISH THE TRANSPORTATION COMMITTEE.

THE TRANSPORTATION COMMITTEE SHALL BE PRIMARILY RESPONSIBLE FOR THE REVIEW, CONSIDERATION AND DEVELOPMENT OF LEGISLATION AND RECOMMENDATIONS RELATING TO ISSUES OF TRANSPORTATION.

THE TRANSPORTATION COMMITTEE IS INTENDED TO BENEFIT ALL CROW TRIBAL MEMBERS, WHO ARE CONSIDERED THE "MOST VALUABLE" TRIBAL RESOURCE.

THE ESTABLISHED CROW LEGISLATIVE RULES OF ORDER SHALL APPLY AT ALL TIMES TO THIS ESTABLISHED TRANSPORTATION COMMITTEE.

THE ATTACHED, INCORPORATED BY REFERENCE AS IF STATED HEREIN BYLAWS ARE HERBY ESTABLISHED, ADOPTED AND APPROVED.

THIS RESOLUTION SHALL TAKE EFFECT IMMEDIATELY UPON PASSAGES BY THE CROW LEGISLATURE.
