Legislative Resolution No. 10-12

Introduced by Senator C.J. Stewart, Black Lodge District

A Legislative Resolution Titled:

A Resolution of the Crow Tribal Legislature to Establish a Legislative Fish and Wildlife Committee

WHEREAS, the Crow Tribal Legislature ("Legislature") is authorized to adopt resolutions for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians; and

WHEREAS, the Crow Tribe has a Reservation with approximately 2.2 million acres of outstanding fish and wildlife habitat and a diverse array of fish and wildlife species, which altogether historically have not received sufficient management attention by the Crow Tribal government;

WHEREAS, the conservation and proper management of Crow Tribal fish and wildlife and their habitat is a vital concern and a top priority of the Crow people and the Crow Tribal Legislature;

WHEREAS, reviewing proposed laws, regulations, and intergovernmental agreements pertaining to the management of fish and wildlife and their habitat is currently a function of the Natural Resources Committee, which has general oversight authority over all issues related to natural resources.

Now, therefore, be it hereby resolved by the Crow Tribal Legislature in Regular Session:

That there is established a Committee on Fish and Wildlife Management which shall exercise concurrent jurisdiction with the Natural Resources Committee;

That all rules of procedure and by-laws governing the Fish and Wildlife Committee be those which are exercised by the Natural Resources Committee, with all appropriate changes made to reflect the intent of the Committee established by this Resolution;

That this Resolution take effect immediately upon passage by the Crow Tribal Legislature.
