Statement of legislative findings:

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions, regulations, and guidelines for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians; and

WHEREAS, the Crow Legislative Branch exerts its Sovereignty and recommendation; and

WHEREAS, Mrs. Vianna Stewart does currently hold the position of OST Trust Fiduciary for the Crow Agency office at the Bureau of Indian Affairs; and

WHEREAS, Mrs. Vianna Stewart served in the U.S. military and has many years of experience with the Bureau of Indian Affairs and would be a great asset to the Crow Nation as well as the Bureau of Indian Affairs.

THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATIVE BRANCH IN REGULAR SESSION:

THAT, the Crow Legislative Branch makes a strong recommendation to the Secretary of Interior to consider Mrs. Vianna Stewart to the position of Superintendent of the Crow Agency Bureau of Indian Affairs office.

FURTHER, this Resolution of Recommendation to the Secretary of Interior to consider, Mrs. Vianna Stewart to the position of Superintendent of the crow Agency Bureau of Indian Affairs office, shall take effect immediately upon passage by the Crow Tribal Legislature.
