A Legislative Resolution Titled:

A Resolution of the Crow Tribal Legislature to Nominate and Support William Yellowtail to Represent Indian Farmers and Ranchers on the Newly Established National Council for Native American Farming and Ranching of the United States Department of Agriculture

Legislative Findings:

WHEREAS, the Crow Tribal Legislature ("Legislature") has the power and duty under Article V, Section 2 of the 2001 Crow Constitution to promulgate and adopt resolutions in accordance with the 2001 Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Crow Tribe entered into the Fort Laramie Treaty of 1868 with the United States for the purpose of establishing the Crow Indian Reservation as a permanent homeland with the intent of becoming viable farmers and ranchers; and

WHEREAS, very few Crow Indians have been able to successfully maintain farming and ranching operations on the Crow Indian Reservation, contrary to one of the main purposes of the 1868 Fort Laramie Treaty and long-standing goals of the Crow Tribe throughout history; and

WHEREAS, the United States Department of Agriculture (hereinafter "USDA") and its various agencies are responsible for administering programs and services which can and should assist and uplift Crow Indians who are interested in maintaining agricultural livelihoods and to enjoy the productive use of their land; and

WHEREAS, USDA recently settled the class-action lawsuit known as the *Keepseagle* case, which alleged past discrimination by the federal government against American Indian farmers and ranchers seeking assistance from the USDA; and

WHEREAS, part of the *Keepseagle* Settlement requires the USDA to establish a fifteen member national advisory council to ensure that American Indian farmers and ranchers participate in and benefit from USDA programs and services; and

WHEREAS, the Council for Native American Farming and Ranching will be comprised of eleven American Indians and four senior officials of the USDA; and

A Resolution of the Crow Tribal Legislature to Nominate and Support William Yellowtail to Represent Indian Farmers and Ranchers on the Newly Established National Council for Native American Farming and Ranching of the United States Department of Agriculture WHEREAS, the current Agriculture Secretary, Tom Vilsack, has stated that: "The Council for Native American Farming and Ranching will help native governments, businesses, farmers and ranchers partner with USDA to create jobs, drive economic growth and strengthen tribal communities;" and

WHEREAS, William "Bill" Yellowtail, an enrolled Crow tribal member, is a Crow Reservation landowner and cattle rancher from the Wyola (Mighty Few) District with a very distinguished career in public service; and

WHEREAS, Bill Yellowtail has long advocated for American Indian self-sufficiency and onreservation economic development; and

WHEREAS, the Legislature believes Bill Yellowtail would provide excellent representation and counsel to the USDA for and on behalf of Crow tribal farmers and ranchers as well as American Indian farmers and ranchers from each of the tribal nations across the United States.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATURE IN REGULAR SESSION:

That William "Bill" Yellowtail of the Wyola (Mighty Few) District is formally nominated and recommended for appointment by the United States Department of Agriculture to serve on the newly established Council for Native American Farmers and Ranchers.

BE IT FURTHER RESOLVED:

That the written statement of acceptance by Bill Yellowtail shall be included as an attachment to this tribal resolution and made a part of the permanent legislative record as contained in the official journal of the January 2012 quarterly session.

BE IT FURTHER RESOLVED:

That this resolution shall be considered a good-faith measure on behalf of the Crow Tribal Legislature to honor and implement the Statement of Purpose as contained in the 1996 Mutual Agreement Between the USDA and the Crow Tribe as authorized by Crow Tribal Council Resolution 96-16B. The 1996 Mutual Agreement and Resolution 96-16B shall be attached and considered a part of this resolution as if stated herein.

BE IT FINALLY RESOLVED:

That the Secretary of the Legislature is hereby directed to immediately provide Agriculture Secretary Tom Vilsack with a certified copy of this resolution via certified mail.

We are privileged to live on the finest agricultural real estate in the country, right here on the Crow Reservation. Having grown up and made my own living on my family's cattle ranch outside of Wyola, I am keenly aware of the power of our landscape to define who we are and to sustain us. It is that formative connection with our mountains, valleys and streams that drives my passion for and loyalty to our homeland and our life-ways.

It is my firm conviction that we Crows and Native Americans should be in position to live productively, independently and honorably upon our lands — and that we have every potential to do so in the future. I also believe that it is the Indian farmers and ranchers who will serve as responsible stewards of our soil, water and landscape for future generations. Sadly, many of us have been reduced to passive, even absentee, lessors. I believe that, given appropriate encouragement, education and structural support, more of us can take direct command of the productivity and the destiny of our land base. Our potential only needs to be realized.

Besides having been an agricultural producer myself, I can claim a life of experience in public policy on behalf of Crow Indians and Native Americans at large. I have worked in tribal government; been elected to represent our interests in the Montana State Senate; elevated Native American interests and agriculture

to my highest priorities as Regional Administrator of the U.S. Environmental Protection Agency; and was keynote speaker for the Governor's Food and Agriculture Summit. I presently serve on the board of directors of the Rural Landscape Institute, a Bozeman, Montana based non-profit organization whose purpose is to promote the viability of independent agriculture and rural communities. I believe these experiences will lend well to my service on the Council for Native American Farming and Ranching.

Thank you for your consideration. I am deeply grateful and will serve faithfully if successfully appointed.

MUTUAL AGREEMENT

Between the

UNITED STATES DEPARTMENT OF AGRICULTURE

and

THE CROW TRIBAL COUNCIL

and

THE CROW CONSERVATION DISTRICT

For their Cooperation in the Conservation of Natural Resources

THIS AGREEMENT is between the United States Department of Agriculture (USDA) and the Crow Tribal Council.

The authority of USDA to enter into this agreement is the Soil Conservation and Domestic Allotment Act, 16.590; the Department of Agriculture Reorganization Act of 1994, Public Law No. 103-354; and Secretary's Memorandum No. 1010-1, dated October 20, 1994. The Crow Tribal authority is defined in Crow Tribal Resolution 96-16B passed on January 13, 1996.

STATEMENT OF PURPOSE

The parties have the common objective of assisting people in their efforts to utilize and manage natural resources in accordance with their capabilities and needs for protection and improvement. Each party is independent, has its respective responsibilities, yet recognizes the need to coordinate as a federal, state and local partnership for the successful delivery of conservation programs related-to-our-soil, water, air, plant, animal, and human resources. Therefore, the parties will cooperate to implement their respective long-range natural resources conservation programs considering available resources, statutory authorities, and regulations. The parties will develop appropriate agreements to further define this relationship.

IT IS UNDERSTOOD THAT:

Broad-based conservation programs delivered through the cooperation of the USDA, the Crow Tribe, and the Crow Conservation District are vital to the protection of the natural resources, economic stability and well-being of our Nation.

The parties reaffirm the relationship between the USDA, the Crow Tribe, and the Crow Conservation District. The Secretary will continue, within the terms of various statutes administered by USDA, to carry out broad conservation programs of assistance encompassing technical, research, educational, and financial assistance to land owners and users through the Crow Conservation District and the Crow Tribe.

The parties also recognize and encourage a continued commitment from the Crow Tribe in aiding administration, coordination, financing, and the delivery of conservation programs through the Crow Conservation District and the Crow Tribal Government.

This Agreement establishes an enduring basis for cooperation and assistance between the parties to achieve common natural resources conservation goals and objectives. Authority to carry out specific projects or activities, such as the transfer of funds, acquisition of services, and property will be carried out under separate agreements. The parties will encourage other natural resource related agencies to develop similar agreements.

The signatories will be in compliance with the nondiscrimination provisions contained in Titles VI and VII of the Civil Rights Act of 1964, as amended, the Civil Rights Restoration Act of 1987 (Public Law 100-259) and other nondiscrimination statutes, namely, Section 504 of the Rehabilitation Act of 1973, Title IX of the Education Amendments of 1972, the Age Discrimination Act of 1975, Americans with Disabilities Act of 1990, and in accordance with regulations of the Secretary of Agriculture (7 CFR-15, Subparts A & B), which provide that no person in the United States shall, on the grounds of race, color, national origin, age, sex, religion, marital status, or disability be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity receiving federal financial assistance from the Department of Agriculture or any agency thereof, that the Crow Tribe may provide for Tribal hiring preference in accordance with Indian Reorganization Act of 1934 (25 U.S.C. 479).

This agreement can be modified or terminated at any time by mutual consent of all parties or can be terminated by any party by giving 60 days written notice to the others.

This agreement supersedes all previous Memorandums of Understanding.

NOW, THEREFORE BE IT RESOLVED, that the Crow Tribal Council wishes to form the Crow Conservation District based upon the Crow Reservation boundary and Tribal Law to provide quidance to the NRCS Crow Agency Office;

BE IT FURTHER RESOLVED, that the Crow Tribal Council directs the Chairperson to write a letter to the FSA statewide Steering Committee requesting that FSA designate the external boundary of the Crow Reservation as an Area Committee for FSA under the 1994 Reorganization Act;

PASSED, APPROVED AND ADOPTED, by the Crow Tribal Council this 13th day of January, 1996, with unanimous votes for adoption and _-0-_ votes against adoption.
