**A Resolution of the Crow Tribal Legislature to Modify the Fiscal Year 2012  
Legislative Branch Budget**

Legislative Findings:

**WHEREAS**, the Crow Tribal Legislature (“Legislature”) has the power and duty under Article V, Section 2 of the 2001 Crow Constitution to promulgate and adopt resolutions in accordance with the 2001 Constitution and federal laws for the governance of the Crow Tribe; and

**WHEREAS**, the Legislature has the constitutional authority to provide for the fiscal management of its own budget and is therefore responsible for and in control of its budget for fiscal year 2012; and

**WHEREAS**, the Revenue Committee of the Legislature (“Revenue Committee”), pursuant to Section 7(B) of the 2007 Crow Tribal Fiscal Management Act and Section IV(B) of the Revenue Committee By-Laws, has the power to recommend modifications to the approved annual Legislative Branch budget; and

**WHEREAS**, the Revenue Committee has reviewed current and projected fiscal year expenditure amounts and the available remaining Legislative Branch budget; and

**WHEREAS**, the Revenue Committee has determined, after review and deliberation of the budget and the priorities and policy goals of the Legislature, that it is in the best interests of the Legislature to modify the fiscal year 2012 budget in accordance with this resolution.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL  
LEGISLATURE IN SPECIAL SESSION:**

That the Fiscal Year 2012 Crow Legislative Branch budget is hereby modified as follows:

**BE IT FURTHER RESOLVED:**

That, according to the modifications made herein this resolution, the Legislative Branch Fiscal Year 2012 line item "Contracted Services" shall now be for the amount of sixty-two thousand one-hundred dollars (\$62,100) and the line item "Travel/Off-Reservation" shall now be for the amount of eighty-seven thousand five-hundred dollars (\$87,500).

**BE IT FURTHER RESOLVED:**



A certified copy of this tribal resolution shall be immediately delivered to the Tribal Comptroller and Tribal CPA by the Secretary of the Legislature.




