A Legislative Resolution Titled:

A Resolution of the Crow Tribal Legislature confirming Jacquelyn Stewart as the Cabinet Head of the Health and Human Services

WHEREAS, the Crow Tribal Legislature ("Legislature") is a separate and distinct branch of government under the 2001 Constitution of the Crow Tribe; and

WHEREAS, the Crow Tribal Legislature ("Legislature") has the power and duty under Article V, Section 2 of the 2001 Crow Constitution to promulgate and adopt resolutions and guidelines in accordance with the 2001 Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Legislature has the lawful authority to confirm Crow Tribal Executive Branch cabinet heads which are nominated by the Crow Tribal Executive Branch Chairman, in accordance with Crow Tribal Joint Action Resolution No. 02-04; and

WHEREAS, the position of Cabinet Head of Crow Tribal Health and Human Services Department is of vital importance to achieving the full potential of members of the Crow Tribe; and

WHEREAS, it is critical that the position of Cabinet Head of Health and Human Services and Human Services be filled by an individual with extensive experience in the areas of healthcare and health policy fields; and

WHEREAS, the Chairman of the Executive Branch has selected Jacquelyn Stewart to serve as Cabinet Head of Health and Human Services Department; and

WHEREAS, Jacquelyn Stewart is a member of the Crow Tribe with a commendable history of service to the Crow Tribal Community; and

WHEREAS, Jacquelyn Stewart has extensive experience in the fields of health and human services, and health policy fields, including over three decades of work experience in the these fields, and is extremely well-qualified to serve in this capacity; and

WHEREAS, Jacquelyn Stewart is recognized nationally, as well as among the Crow Tribal community, as a leader in the field of healthcare and human services; and



NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATURE IN SPECIAL SESSION:

That Jacquelyn Stewart is duly confirmed as the Crow Tribal Health and Human Services Department Cabinet Head and shall exercise all authority in accordance with all applicable federal and Crow tribal law upon approval of the Crow Tribal Legislative Branch.
