A Legislative Resolution Titled:

A Resolution of the Crow Tribal Legislature to Modify the Fiscal Year 2013 Legislative Branch Budget

Legislative Findings:

WHEREAS, the Crow Tribal Legislature ("Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Legislature has the constitutional authority to provide for the fiscal management of its own budget and is therefore responsible for and in control of its budget for fiscal year 2013; and

WHEREAS, the Revenue Committee, pursuant to Section IV(B) of the Revenue Committee By-Laws, has the power to recommend modifications to the approved annual Legislative Branch budget; and

WHEREAS, the Revenue Committee has reviewed current and projected fiscal year expenditure amounts and the available remaining Legislative Branch budget; and

WHEREAS, the Revenue Committee has determined, after review and deliberation of the budget and the priorities and policy goals of the Legislature, that it is in the best interests of the Legislature to modify the fiscal year 2013 budget in accordance with this resolution.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATURE IN SPECIAL SESSION:

That the Fiscal Year 2013 Crow Legislative Branch budget is hereby modified as follows:
