A Legislative Resolution Titled:

A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM DR. LUKE ENEMY HUNTER AS THE TRIBAL CEO

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2(a) of the Crow Tribal Constitution to promulgate and adopt resolutions and in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, pursuant to Article IV, Section 5(a) of the Crow Tribal Constitution, the duties and authorities of the Crow Tribal Chairman includes appointment of cabinet members including a Comptroller who shall be bonded, Chief Executive Officer and other such Cabinet positions adopted by Tribal Ordinance, Resolution or Policy who shall all serve in subordinate positions to the Tribal Officials; and

WHEREAS, the Legislature has the lawful authority to confirm appointments made by the Tribal Chairman to the position of Tribal Chief Executive Officer (hereinafter "CEO") pursuant to Crow Tribal Joint Action Resolution No. 02-04; and

WHEREAS, Chairman Darrin Old Coyote has submitted a letter of nomination for Dr. Luke Enemy Hunter as Tribal CEO; and

WHEREAS, the nomination was referred to the Personnel Committee, which held a confirmation hearing on the record, received testimony from Dr. Enemy Hunter and has resolved to officially recommend confirmation of Dr. Enemy Hunter by the full Legislature; and

WHEREAS, Dr. Enemy Hunter is an experienced public administrator with outstanding education credentials and is well-qualified to capably administer his duties and authorities as Tribal CEO.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATURE IN SPECIAL SESSION:

That Dr. Luke Enemy Hunter is duly confirmed by the Legislature to the position of Crow Tribal Chief Executive Officer and shall exercise all duties and authorities in accordance with Crow Tribal Law and Executive Branch policy.

BE IT FINALLY RESOLVED:

That this confirmation shall become effective immediately upon this tribal resolution being duly adopted by the Legislature and an administration of an oath of office by the Speaker of the House or his designee.
