A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO REPEAL LR 08-12

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter “Legislature” or “Legislative Branch”) has the power and duty under Article V, Section 2(a) of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Crow Tribal Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, in a special legislative session held on June 8th, 2008 the Legislature adopted Legislative Resolution No. 08-12 (titled “Retro Compensation for 2008 Quarterly/Special Sessions and Establishing Administrative Leave With Pay Per Employee After Quarterly/Special Sessions”) which created Branch policy allowing each staff member to earn three (3) days of administrative leave for each quarterly session and one (1) day of administrative leave for each special session; and

WHEREAS, Chapter 9.6 of the Legislative Branch Personnel Practices and Policy Manual (“Administrative Leave”) provides that the House Speaker for purposes such as inclement weather and holiday extensions may grant administrative leave with pay and that administrative leave does not require use of annual or sick leave; and

WHEREAS, there are not clear records of accumulated administrative leave earned and each member of the Legislative Branch staff earns annual leave based on actual work hours each pay period; and

WHEREAS, the Legislature now seeks to simplify and improve Branch policy so as to provide that administrative leave shall be exclusively employer-granted, as determined by the House Speaker in accordance with the Personnel Practices and Policy manual.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATURE IN REGULAR SESSION:


Section 1. Legislative Resolution No. 08-12 is hereby repealed and rescinded in its entirety.

Section 2. All accumulated administrative leave earned by members of the Legislative Branch staff in accordance with Legislative Resolution No. 08-12 is hereby eliminated and made void.

Section 3. This Resolution shall take effect immediately upon being duly-adopted by the Legislature.




