A Legislative Resolution Titled:

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM  
NOMINATIONS TO THE CROW TRIBAL GAMING COMMISSION**

Legislative Findings:

**WHEREAS**, Article V, Section 2(a) of the Crow Tribal Constitution vests the Crow Tribal Legislature (hereinafter “Legislature”) with the power and duty to promulgate and adopt resolutions in accordance with the Crow Tribal Constitution and federal law for the governance of the Crow Tribe; and

**WHEREAS**, CLB No. 14-02 (titled “An Act to Amend Title 23 by Revising the Crow Tribal Gaming Ordinance”) replaced the Crow Tribal Gaming Ordinance of 1994, and was approved by the National Indian Gaming Commission Chairman on December 18th, 2013; and

**WHEREAS**, by revising the Crow Tribal Gaming Ordinance (hereinafter “Gaming Ordinance”) the Legislature seeks to establish absolute accountability and lawfulness in all gaming operations conducted on the Crow Indian Reservation and to ensure the professionalism and economic productivity of all such gaming; and

**WHEREAS**, the Gaming Ordinance established the Crow Tribal Gaming Commission (hereinafter “Gaming Commission”) as a seven-member tribal regulatory agency with administrative rule-making, enforcement, and adjudication power, with Commissioners representing each of the six Districts of the Crow Reservation and one at-large Commission Chairman, each subject to confirmation by the Legislature;

**WHEREAS**, the Economic Development Committee held a confirmation hearing on the record, pursuant to Rule 31 (“Legislative Confirmation Procedure”) on May 14th, 2014 with a secret ballot vote which resulted in an official recommendation for confirmation by the full Legislature.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL  
LEGISLATURE IN SPECIAL SESSION:**

Pursuant to the Gaming Ordinance, each of the following individuals shall be confirmed as members of the Gaming Commission and shall exercise all duties and authorities in accordance with Crow tribal law and applicable federal law:

1. **Victor Dust**, representing the Lodge Grass District, for a two (2) year commencing on May 14th, 2014 and ending May 14th, 2016;
2. **Phillip Beaumont**, representing the Arrow Creek District, for an initial two (2) year term commencing May 14th, 2014 and ending May 14th, 2016;
3. **Bruce House**, representing the Black Lodge District, for an initial two (2) year term commencing May 14th, 2014 and ending May 14th, 2016;
4. **Owena Spotted Horse**, representing Big Horn District for a four (4) year term commencing May 14th, 2014 and ending May 14th, 2018;
5. **Truman “Boogie” Jefferson, Jr.**, representing Wyola District for a four (4) year term commencing May 14th, 2014 and ending May 14th, 2018;
6. **Laverne Old Elk**, representing the Center Lodge District for a four (4) year term commencing May 14th, 2014 and ending May 14th, 2018;
7. **Robert “Hoss” Rides Horse**, Chairman of the Gaming Commission for a four (4) year term commencing May 14th, 2014 and ending May 14th, 2018.


