A Legislative Resolution Titled:

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM
NOMINATIONS TO THE CROW BOARD OF HORSE RACING**

Legislative Findings:

WHEREAS, Article V, Section 2(a) of the Crow Tribal Constitution vests the Crow Tribal Legislature (hereinafter “Legislature”) with the power and duty to promulgate and adopt resolutions in accordance with the Crow Tribal Constitution and federal law for the governance of the Crow Tribe; and

WHEREAS, the Sixth Amendment to and Extension of the Agreement Between the Crow Tribe of Montana and the State of Montana Concerning Class III Gaming authorizes the Crow Tribe to conduct pari-mutuel wagering on live and simulcast horse racing under rules and regulations promulgated by the Crow Board of Horse Racing; and

WHEREAS, CLB No. 14-01 (titled “The Crow Board of Horse Racing Act”), passed by the Legislature in the January 2014 quarterly session and signed into law on January 24th, 2014, established a seven-member Crow Board of Horse Racing, representing each of the six Districts and an at-large Director, as an Executive Branch agency authorized to license and regulate the conduct of live and simulcast horse racing; and

WHEREAS, Chairman Darrin Old Coyote nominated six Crow tribal members to serve on the Board of Horse Racing and the Economic Development Committee of the Legislature held confirmation hearings on the record, pursuant to Rule 31 (“Legislative Confirmation Procedure”) with a secret ballot vote which resulted in an official recommendation for confirmation of each nominee by the full Legislature; and

WHEREAS, each Board of Horse Racing nominee has extensive knowledge and experience in the horse racing industry and meet all qualifications and requirements under Crow tribal law.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL
LEGISLATURE IN SPECIAL SESSION:**

Pursuant to the Crow Board of Horse Racing Act, each of the following individuals shall be confirmed as members of the Crow Board of Horse Racing and shall exercise all duties and authorities in accordance with Crow tribal law and applicable federal law:

1. **Steve Amyotte, Jr.** representing the Lodge Grass District, for a 4-year term commencing on June 5th, 2014 and ending June 5th, 2018;
2. **Henry Rides Horse** representing the Black Lodge District, for a 4-year term commencing on June 5th, 2014 and ending June 5th, 2018;
3. **Wendell Bad Bear** representing the Big Horn District, for a 4-year term commencing on June 5th, 2014 and ending June 5th, 2018;
4. **Isaiah Hugs** representing the Arrow Creek District, for a 2-year year term commencing June 5th, 2014 and ending June 5th, 2016;
5. **Dale Crooked Arm** representing the Center Lodge District, for a 2-year term commencing on June 5th, 2014 and ending June 5th, 2016; and
6. **Richard Old Coyote** representing the Mighty Few District, for a 2-year term commencing on June 5th, 2014 and ending June 5th, 2016;


CERTIFICATION


