A Legislative Resolution of the Crow Tribal Legislature titled

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO RECOGNIZE THE
CROW UNITED FULL GOSPEL CHURCH (LODGE GRASS CHURCH/CARPENTER
CHURCH) ON THE CROW RESERVATION**

Statement of Legislative Findings:

WHEREAS, the Crow Tribal Legislative Branch (hereinafter “Legislature”) has the power and duty pursuant to Article V, Section 2(a) of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Constitution for the governance of the Crow Tribe of Indians; and

WHEREAS, Legislative Resolution 10-20 (Branch Policy and Procedure for Legislative Resolutions) provides in Section 1, that Legislative Resolutions are an expression of the voice of the elected Senators of the Legislature, which is based on the inherent sovereign authority of the Crow General Council and which shall be categorized by types of resolutions, including specifically those resolutions “Officially recognizing or supporting programs, actions, or deeds of significance to the positive spirit of the Apsaalooke Nation and its social community; and

WHEREAS, the Crow United Full Gospel Church is recognized as the first church on the Crow Reservation, which was run by Crow Tribal Member Harold Carpenter and has been in existence for sixty-three years (63) and the current Pastor is Guthrie Gary Bird, Sr.; and

WHEREAS, recognition and appreciation for the many years of service for past and current of Pastor Harold Carpenter and Pastor Guthrie Gary Bird for their dedication and commendable service to the Crow People through distinguished service; and

WHEREAS, Legislative Resolution LR 13-02, states that the Crow Tribal Legislature supports the ministers and pastors of the Crow tribal communities in the re-establishment of signage which reads “Jesus is Lord of the Crow Indian Reservation” along interstate 90 near Crow Agency and in other areas on the Crow Reservation.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE TRIBAL LEGISLATURE
IN REGULAR SESSION:**

That the Crow United Full Gospel Church is recognized and honored by the Crow Tribal Legislature for its distinguished service to the Apsaalooke Nation. This Tribal Resolution shall be an official statement of Branch policy by the Crow Tribal Legislature.

That, finally this Resolution shall be considered effective immediately upon passage by the Crow Tribal Legislature.


CERTIFICATION


