# A RESOLUTION OF THE CROW TRIBAL LEGISLATURE APPROVING A SUPPLEMENTAL APPLICATION FOR FEE TO TRUST ACQUISITIONS OF CROW TRIBAL FEE LANDS

## Legislative Findings:

WHEREAS, Joint Action Resolution No. JAR 16-01, approved January 29, 2016, authorized and requested the Secretary of the Interior or his or her designee to acquire in the name of the United States, to hold in trust for the benefit of the Crow Tribe, lands and interests in lands owned by the Crow Tribe in fee simple, as described in Appendix A (the "Property"), and applies to mandatory as well as discretionary acquisitions of lands located both within and outside the boundaries of the Crow Indian Reservation; and

WHEREAS, Section 4 of JAR 16-01 authorizes the Crow Tribal Executive Branch to submit supplemental applications for the United States to acquire additional Tribally-owned fee lands to be held in trust for the benefit of the Crow Tribe, including mandatory as well as discretionary acquisitions, to be added to and incorporated into Appendix A, subject to approval by Legislative Resolution of the Legislative Branch upon the request of the Chairman of the Executive Branch; and

**WHEREAS**, pursuant to Section 4 of JAR 16-01, the Chairman of the Executive Branch has requested the Legislative Branch to approve a supplemental application for the lands and interests in lands listed in the addition to Appendix A designated Appendix A-1; and

WHEREAS, it is the continuing desire and intention of the Crow Tribe to request the United States, through the Secretary of the Interior, to acquire such Tribally-owned fee lands in the name of the United States in trust for the Crow Tribe;

# NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN SPECIAL SESSION:

That pursuant to Section 4 of JAR16-01, the Chairman of the Executive Branch is hereby authorized to prepare and submit a supplemental application(s) for the United States to acquire additional Tribally-owned fee lands to be held in trust for the benefit of the Crow Tribe as listed in Appendix A-1 attached hereto and incorporated by reference.

A RESOLUTION OF THE CROW TRIBAL LEGISLATURE APPROVING A SUPPLEMENTAL APPLICATION FOR FEE TO TRUST ACQUISITIONS OF CROW TRIBAL FEE LANDS

That this Tribal Resolution shall take effect immediately upon becoming duly adopted by the Legislature.
