A RESOLUTION OF THE CROW TRIBAL LEGISLATURE UPHOLDING THE 2001 CONSTITUTION AND BYLAWS OF THE CROW TRIBE OF INDIANS AS THE SOLE GOVERNING DOCUMENT OF THE CROW INDIAN RESERVATION

Legislative Findings:

WHEREAS, the Constitution and Bylaws of the Crow Tribe of Indians of 2001 was adopted by the Crow Tribal membership on July 14, 2001; and

WHEREAS, in December of 2001, the United States Government through former Assistant Secretary of Interior, Neal McCaleb recognized the adoption of the 2001 Constitution "removed any legal authority to continue" under the 1948 Constitution; whereby, the 1948 Constitution was effectively repealed and replaced; and

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, LR 10-20 A Resolution of the Crow Tribal Legislature to Establish Branch Policy and Procedure for Legislative Resolutions, Section 1. Branch Policy Regarding Legislative Resolutions, "The policy of the Legislature shall be that legislative resolutions are an expression of the voice of the elected Senators of the Crow Legislature, and which is based on the inherent sovereign tribal authority of the Crow Tribal General Council, as delegated to the Legislature under the 2001 Constitution" to issue under Subsection 5, Recommendation Resolutions, "statements of support" and Section 6, Recognition and Acknowledgement Resolutions, "[r]esolutions officially recognizing or supporting programs, actions, or deeds of significance to the positive spirit of the Apsaalooke Nation and its social community"; and

WHEREAS, The Legislative Branch of the Crow Tribal Government is aware that public discussion is taking place regarding the "legitimacy" of the 2001 Constitution and Bylaws of the Crow Tribe of Indians. As a public announcement, the Legislative Branch Senators, through their individual oath of office hereby uphold the 2001 Constitution and continue to do so accordingly; and

WHEREAS, that the 2001 Constitution has survived all challenges and remains the Crow Tribe's governing document. Such challenges have been resolved on the merits procedurally and substantively in the Crow Tribal Court case: Greybull Huber v. Venne et.al., Civil Case No. 04-001 on July 27, 2005. The United States District Court for the District of Montana has also dismissed the same type of challenges on procedural grounds in the matter of Plains Bull v. Crow Nation Executive, Legislative, and Judicial Branches in 2010; and

WHEREAS, these decisions strengthened the foundation of the government-to-government relationship between the Crow Tribe and federal government for the past 16 years. As such, any issues surrounding the legality of the 2001 Constitution have been laid to rest; and

WHEREAS, the Legislative Branch is also aware that public forums are taking place facilitating the discussion of whether procedures of the 1948 Crow Constitution are available to contest the current 2001 Constitution. Such facilitation is misinformation to the Crow Tribal membership and causes misplaced conclusions; and

WHEREAS, that based on the government-to-government relationship between the United States and the Crow Tribe, the 2001 Constitution has provided the foundation for many services, entities, infrastructure, settlements, agreements, works in progress that must continue to move forward; whereby, any recognition of authority of the 1948 Constitution contradicting this government-to-government relationship will be contrary to the best interests of the Crow Tribe, which will result in instability of the current government; and

WHEREAS, the 2001 Constitution defines the current General Council under Article I and the available means to institute government reform. This process works in accordance with Article IX of the 2001 Constitution by either the Initiative or Referendum process for Amendments. This avenue provides the legal means for the Crow Tribal Membership for government reform.

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN REGULAR SESSION:

Pursuant to the court cases resolving this issue, any purported actions taken pursuant to the 1948 Constitution would be considered void ab initio-or without legal standing from their onset.

BE IT FURTHER RESOLVED:

Copies of the 2001 Constitution and current Election Ordinance are available to the public and on the website at www.ctlb.org. The Legislative Branch, as the People's Branch fully support the Crow Tribal membership in government reform but with a responsible, transparent and legal approach that will serve the best interests of the Tribe going forward.
