A Legislative Resolution titled:

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM
NOMINATIONS TO THE BOARD OF COMMISSIONERS FOR THE APSAALOOKE
NATION HOUSING AUTHORITY**

Legislative Findings:

WHEREAS, Article V, Section 2(a) of the Crow Tribal Constitution vests the Crow Tribal Legislature (hereinafter “Legislature”) with the power and duty to promulgate and adopt resolutions in accordance with the Crow Tribal Constitution and federal law for the governance of the Crow Tribe; and

WHEREAS, Legislative Resolution 10-20 “A Resolution of the Crow Tribal Legislature to Establish Branch Policy and Procedure for Legislative Resolutions” provides authority for enacting “[r]esolutions providing for the confirmation of tribal officers . . . in accordance with established tribal law and legislative procedure; and

WHEREAS, Crow Legislative Bill 17-03 “An Act to Repeal and Replace the Crow Tribal Housing Ordinance” 19-2-105 provides, “Housing Commissioners shall be appointed by the District Senators of the Legislature, through majority decision as expressed in writing to the Speaker of the House. All appointments shall be subject to confirmation by the Legislature”; and

WHEREAS, on August 29-31, 2017, the following nominations were made for by their respective District Senators’ consensus as documented to the Speaker of the House:

1. Calvin E. Leider Jr. for the Valley of the Give Away District,
2. Marilyn R. Simpson for the Arrow Creek District,
3. Bryan Rogers, Jr. for the Black Lodge District,
4. Jeff Packs The Hat for the Valley of the Chiefs District,
5. Ronnie Stewart for the Mighty Few District,
6. Dr. Lanny Real Bird for the Center Lodge District; and

WHEREAS, on August 29-31, 2017, the Infrastructure Committee held confirmation hearings on record pursuant to Rule 31 “Legislative Confirmation Procedure” and made recommendations for all six nominees by a secret ballot vote which resulted in official recommendation for confirmation by the full Legislature; and

WHEREAS, the full Legislature on August 31, 2017 voted to confirm all six of the above-named nominations to the Board of Commissioners for the Apsaalooke Nation Housing Authority.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL
LEGISLATURE IN SPECIAL SESSION:**

Section 1. Confirmation of Board of Commissioners and Reporting. The following individuals are hereby confirmed as Board of Commissioners for the Apsaalooke Nation Housing Authority and shall exercise all duties and authorities in accordance with Crow Tribal law and applicable federal law, and shall provide quarterly reporting to the Legislative Branch with guidelines contained in LR 10-21, upon entering the oath of office.

1. Calvin E. Leider Jr. for the Valley of the Give Away District
2. Marilyn R. Simpson for the Arrow Creek District
3. Bryan Rogers, Jr. for the Black Lodge District
4. Jeff Packs The Hat for the Valley of the Chiefs District
5. Ronnie Stewart for the Mighty Few District
6. Dr. Lanny Real Bird for the Center Lodge District

Section 2. Terms. The Board of Commissioners shall call a meeting immediately for the purpose of establishing the terms of the board according to CLB 17-03, 19-2-102.

Section 3. Effective Date. This Resolution shall take effect immediately upon its passage by the Full Legislature.
