A Legislative Resolution Titled:

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE APPROVING THE
ADMINISTRATIVE RULES, POLICIES, PROCEDURES AND REGULATIONS AS
ADOPTED BY THE CROW NATION HOUSING BOARD OF COMMISSIONERS
(REPEALING AND REPLACING PERSONNEL AND FINANCIAL MANAGEMENT
POLICIES ADOPTED OCTOBER 5, 2017) AND OFFICIAL CONCLUSION OF
PUBLIC COMMENT PERIOD**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter “Legislature”) has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Crow Tribal Constitution, federal laws and tribal laws for the governance of the Crow Tribe; and

WHEREAS, the Housing Board of Commissioners (hereinafter “Commissioners”) as established by CLB 17-03 (titled “An Act to Repeal and Replace the Crow Tribal Housing Ordinance”) is the governing and rule-making authority for the Crow Housing Tribal Authority; and

WHEREAS, CLB 17-03, 19-2-107 provides for the Rule-Making Authority of the Commissioners; 19-2-108 provides for the Legislative Approval of the proposed rules during a public comment period; and

WHEREAS, Pursuant to LR 17-07, the public comment period convened on October 5, 2017 and has now ended; and

WHEREAS, on October 5, 2017 the Infrastructure Committee held a meeting to review the proposed rules, policies, procedures and regulations as adopted by the Commissioners and a committee recommendation was made to the full legislature to approve the proposal;

and

WHEREAS, On October 31, 2017, after the conclusion of the public comment period pursuant to CLB 17-03, 19-2-108 the Housing Board Commissioners needed to update the previous policies on Personnel and Financial Management, whereby the Infrastructure Committee convened a meeting on November 2, 2017 and made the full recommendation for repealing and replacing these two policies.

**NOW, THEREFORE BE IT HEREBY RESOLVED BY THE CROW TRIBAL
LEGISLATURE IN SPECIAL SESSION:**


That the Legislature hereby approves the attached Rules, Policies, Procedures and Regulations including the replacement Personnel and Financial Management policies as adopted by the Crow Housing Board of Commissioners on October 31, 2017, whereby all public comment period has officially concluded.

This Legislative Resolution shall take effect immediately upon becoming duly adopted by the Legislature; and, the Rules, Policies, Procedures and Regulations shall become effective after on the date this resolution is passed.
