A Legislative Resolution Titled

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE FOR ALL FEDERAL
AGENCIES, OF ALL CROW TRIBAL ASSETS, FUNDS INCLUDING ALL LENDING
INSTITUTIONS ON ALL FUNDS DRAWN ON CROW TRIBAL FINANCIAL
RECORDS**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") is the lawmaking Branch with the authority and duty to promulgate and adopt resolutions in accordance with the 2001 Crow Tribal Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the 2001 Crow Tribal Constitution Article IV, Section 4, b., Executive Branch officials must provide for the fiscal management of the Executive Branch and prepare complete financial reports for the Crow Legislative Branch on a quarterly basis and biannual reports for the Crow Tribal General Council.

WHEREAS, the Legislature passed Legislative Resolution 10-21, Establishing reporting standards and to enhance reporting to the Crow Tribal General Council, procedural and content for reporting to the Legislative Branch, and to review complete financial reports from all agencies, departments and instrumentalities, and any other instrumentality that holds, manages, invests, or otherwise effects tribal accounts and assets.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL
LEGISLATURE IN REGULAR SESSION:**

Section 1. Call to the President of the United States to order all departments and agencies of the United States that hold or manage any Crow tribal asset to provide a written audit of all such tribal assets including all assets held in trust, including monetary value, investment return, if applicable, and terms of management of the asset.

Section 2. Call to the Secretary of Interior to hold accountable the Office of the Special Trustee, Bureau of Reclamation and Bureau of Indian Affairs to order all departments and agencies of the United States that hold or manage any Crow tribal asset to provide a written audit of tribal assets, including monetary value, investment return, if applicable, and terms of management of the asset.

Section 3. Call to Montana's Congressional Delegation.

The Branch Officers of the Crow Tribal Legislature shall ensure that a copy of this Tribal Resolution be at once delivered to the United States Senator Steve Daines, United State Senator Jon Tester and to Congressman Greg Gianforte.

Section 4. Office of Special Trustee to order all departments and agencies of the United States that hold or manage any Crow tribal asset to provide a written audit of tribal assets, including monetary value, investment return, if applicable, and terms of management of the asset.

Section 5. Bureau of Indian Affairs order all departments and agencies of the United States that hold or manage any Crow tribal asset to provide a written audit of tribal assets, including monetary value, investment return, if applicable, and terms of management of the asset.

Section 6. Notice to Crow Tribal Executive Branch Officials


The Branch Officers of the Crow Tribal Legislature shall ensure that a certified copy of this Tribal Resolution be at once delivered to the Executive Officers of the Crow Tribe.

Section 7. Effective Date

This Tribal Resolution shall take effect immediately upon being duly adopted by the Crow Tribal Legislature.




