A Legislative Resolution Titled

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM LESLIE  
LEFT HAND AS THE CABINET HEAD OF ECONOMIC DEVELOPMENT"**

Legislative Findings:

**WHEREAS**, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

**WHEREAS**, JAR 02-04, created requirements and states Legislative Branch has a desire to insure that persons selected for the key positions of Cabinet Heads and CEO, are adequately qualified for the positions and to insure that they are adequately qualified shall comply with the following standards be at least twenty-five (25) years old, possess a High School Diploma or Equivalent, shall have no felony convictions, to provide for the utmost protection of the Tribal membership, Tribal funds, assets and resources; and

**WHEREAS**, Article IV, section 5(a) states, the Chairman of the Executive Branch has the duty and authority to appoint Cabinet members including a comptroller who shall be bonded, Chief Executive Officer, and other such Cabinet positions adopted by Tribal Ordinance, Resolution, or Policy, who shall serve in subordinate positions to the Tribal Officials; and

**WHEREAS**,  
the Legislative Branch LR 10-09 establishes rules (1-10) for confirming nominations from the Executive Branch Chairman and the Judicial Branch Crow Tribal Chief Judge. The legislature has the lawful authority to confirm Executive Branch cabinet heads, and members of certain boards, commissions, offices, and Crow Tribal committees and Judicial Branch nominations for the Appellate Judge of the Crow Court of Appeals; and


**WHEREAS**, the Legislative Branch Economic Development Committee held a committee meeting pursuant to LR 10-09 for confirmation hearing to interview the Chairman's nominee Leslie Left Hand on July 18, 2018. The Economic Development committee held a secret ballot vote and received a recommendation for passage on the floor of the next Regular Session or Special Session; and

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL  
LEGISLATURE IN SPECIAL SESSION:**

That Leslie Left Hand is duly confirmed as the Economic Development Cabinet Head and shall exercise all authority and duties in accordance with applicable federal and Crow tribal law and shall provide quarterly reporting to the Legislative Branch with guidelines contained in LR 10-21, upon taking of the oath of office. This resolution shall take effect immediately upon passage by the Crow Tribal Legislature.
